Sub: Revision of Margins of Fair Price Shops.

Most Hon'ble Prime Minister Sir,

We would beg of your forgiveness for bothering you over and over again with our prayers for upward revision of our Margins and, unfortunately, we are being given the same reply that as per NFSA, the responsibility in this regard lies on the State Govts. / Union Teritorries.

We would relevantly submit in this regard that when the Rice, Wheat & Coarsegrain were being distributed at prices fixed in the NFSA i.e. Rs. 3/- per kg, Rs. 2/- per kg & Re. 1/- per kg respectively the determination of our Margins would have depended on the State Govt. over and above the Central share of the Margins.

At present, Rice, Wheat & Coarsegrains are being distributed in the PDS under a new scheme i.e. PMGKAY free – of – Cost and hence there can be no question or scope for the State Govts. / Union Teritorries to have any role in fixation of the Margins of the Fair Prie Shop Dealers.

Under the above stated circumstances, we would most humbly pray to your Honoured Self with folded hands kindly to consider taking decision in the matter of upward revision of our Margins so that the Fair Price Shop Dealers may run their Shops viably and are ensured two – square meals per day for themselves and members of their respective families and most kindly save us from financial damnation and decay.

We are approaching you with begging bowls in our hands, kindly do not deprive us Hon'ble Sir.
