It is a fact that in the Budget, PDS has been considered as a issue of Union Govt. but our suggestions in so many occasions and in so many meetings with Distinguished Executives is either rejected and ignored. For us, it is altogether hopeless.

As per our non-intellectual observation, we have noticed some points and interested to highlight those which are briefly narrated as follows:-

DEALER'S MARGIN

It is painful to note that Revision of FPS Dealer's Margin in the Budget of 2025-'26 is "ZERO" and obviously outcome will be "ZERO" which is a painful blow for us.

In the NFSA, it is recorded that a periodical revision of Dealer's Margin in every 3 (three) years is a must and just in many ways. As per provision of the Act, revision is due for 3 (three) slabs from 2016 to 2025. During the period one uncalculated enhancement was made @20/- (Rupees Twenty) only per quintal in April 2022 But for the period of 2016 to 2025, the Central Govt. is absolutely silent for us, it is unfair and unjust.

Atmanirbhar in Pulses:-

We have been delighted to learn from the contents of Union Budget about the procurement mechanism from Producers directly but we are in dark about the Distribution mechanism. The FPS Dealers being the direct chain of distribution mechanism, are interested to take part in the mechanism of distribution system of Pulses for which we are competent enough and authorised also and arrangement may be made accordingly.
