## Meeting Details

A virtual conference was held today, 04.02.2026, Wednesday, from 1:00 PM to 4:45 PM, under the chairmanship of All India Organization President Shri Kacham Krishnamurthy and in the presence of the leadership of eighteen states, including (1) Andhra Pradesh, (2) Arunachal Pradesh, (3) Assam, (4) Bihar, (5) Chhattisgarh, (6) Delhi, (7) Jharkhand, (8) Karnataka, (9) Kerala, (10) Maharashtra, (11) Odisha, (12) Punjab, (13) Rajasthan, (14) Telangana, (15) Uttarakhand, (16) Uttar Pradesh, (17) West Bengal, (18) Jammu and Kashmir.

At the beginning of the meeting, a minute's silence was observed to pay tribute to the late Ramkumar Godara, who passed away on January 28th. Ramkumar Godara was the father of Shri Shishpal Godara, the Haryana president and one of the presidents of the All India Organization.

First, there were strong protests against the Union Budget.

Others who should be invited to help:

1. Arrangements should be made to invite at least four Honorable Members of Parliament from each state and urge them to raise the issue of ration shop owners' livelihoods in the Lok Sabha and Rajya Sabha.

A significant amount of funding is needed to make this Historic event a success. For this purpose, currently: All India Organization Treasurer Shri Dharanidhar is requesting state-wise donations (Rs. 2,000 for larger states and Rs. 10,000 for smaller states) by February 28th.

To make the said seminar a success, the responsibility is mainly given to Shri Girish Tewari (UP) and Shri Saurabh Gupta (Delhi). Their primary responsibility is to prepare a budget of the expenses to make the said organizational activities a success and submit it to the National General Secretary, Shri Biswambhar Basu.

In view of the budget, every ration dealer wishing to participate in the seminar will have to pay a registration fee of a certain amount.

By this February, each leader will have to hold a meeting in their respective states to promote this program.

If the Central Government does not take a decision on the current dire financial situation of ration dealers from the said seminar, then we will organize a "continuous relay hunger strike" program with ration dealers from two states every day at Jantar Mantar in New Delhi, starting from March 23. On which day - which states will have to be present on the relay hunger strike stage from 11 am to 4 pm - this will be decided through a "lottery".

## That means we-

1. Before the seminar,
2. If you don't get anything, take to the streets and protest.

Every ration dealer, regardless of party affiliation, must take turns participating in the seminar first, or else in the "relay hunger strike".

The format of the poster or banner for the seminar movement will be sent by the organization via WhatsApp in due course.

The leadership of any state cannot withdraw from the movement in the name of elections for the assembly elections in the five states.

Today in Parliament, Maharashtra and Dadra and Nagar Haveli have been declared as "extreme poverty free" states. In that case, if there is a conspiracy to abolish the rationing system in those two states, a movement will have to be organized.

In this budget, Rs. 1,102 crore has been allocated for the salaries of ministers and entertainment of guests of the country.

There are indications of further reductions in Government banks. A review committee has been formed for this.

6000 (six thousand) crore Rupees has been allocated for the census.

## Other important points:

The efforts to organize a continuous protest from January 28th to February 7th in Uttar Pradesh are commended.

The decision to open three ATM counters in Rajasthan without paying six months' commission was opposed.

A call was made to thwart the attempt to implement the DBT system in Jammu and Kashmir.

It was informed at the meeting that money was being deducted from cards in the name of updating data in Delhi.

As per the proposal of the State of Bihar, special deputation will be provided regarding the additional margin under the NFSA Act.

The Andhra Pradesh unit has promised that at least 500 shopkeepers will be present at the protest.

Any protest will be organized after the leadership of one state oversees the preparations for the protest in the other state.

The leaders from Telangana and Maharashtra propose that all leaders of the All India leadership who are not attending the organization's meetings and who are not contributing financially as per the organization's decisions should be removed from the organization's responsibilities by issuing a show-cause notice.

With no further discussion, the meeting's chairman, Shri Kacham Krishnamurthy, declared the meeting closed and called on every ration dealer in the country to participate in the movement.
