## Minutes of the National Working Committee Meeting held on 12.12.2022 at 11 am at "Radha Gobind Celebration Hall" Buldhana, Maharashtra

Shri Prahlad Damodar Das Modi, Senior Vice – President presided over the meeting.

We held separate meetings with "Kishan Morcha" after our National Working Committee jointly with the "Akhil Maharashtra Rajya Sasta Dhanya Dukandar & Kerosene Parowanadharak Mahasangh".

### It has been resolved in the meeting as follows :-

It is a matter of great insult not only to the Union Govt. but to the Parliament as well because of the irresponsible, un – parliamentary and un – civil action on the part of Hon'ble AAP MP., Shri Sanjay Singh for calling the Fair Price Shop Dealers as crook in the Rajya Sabha on 09.12.2022 when he was protesting the action of the Union Govt. with holding "Door Delivery" of Ration in Delhi UT.

To protest against such uncivil & un – parliamentary uttering of Shri Sanjay Singh, Hon'ble MP., Rajya Sabha our National Federation has decided to burn an "effigy" (KUSH PUTUL) of Shri Sanjay Singh on 26.12.2022 in the Capital City of very States / UTs as a mark of our protest and condemnation.

It has been decided to hit the streets on protest simultaneously with our Appeal to the Hon'ble Supreme Court will be held in all the State Capitals in protest against the Central decision de – privatisation of Fair Price Shops. The pre – declared dates of different levels movement would be finalised in an emergency meeting Virtually within this month of December, 2022 (23.02.2022).

It has also been resolved that Shri Nagendra Nath Jena President of our Odisha State Committee has been esteemed to move any Court on behalf of our Federation regarding de – privatisation of Fair Price Shops by the Odisha State Govt.

To move before the Hon'ble Supreme Court, financial assistance from all the Private Fair Price Shop Dealers is needed and for that purpose a Sub – Committee with the Chairmanship of Shri D. N. Patil has been made and he has also been authorised to keep the fund to be raised in this regard.

We must request the NITI AAYOG kindly to consider convening atleast 2 (two) meetings with our Federation every year so that we may keep ourselves updated about the developments as also may place our submissions.

The 1<sup>st</sup> meeting of its kind with the North – Eastern States will be held by us at Guwahati on 18.12.2022.
